Overall Feedback Report on the institution: Teachers

Feedback from the faculty members on the overall facilities provided by the institution including grievance redressal system is taken by the IQAC. IQAC finds it encouraging .

Total (05) five questions were asked and twenty-eight (28) respondents took part in the survey.

Maximum score will be 112 (100%) per item.

The glimpses of their responses are as follows:

Observation:

1) Status of library facility:

The institution has tried to create library facilities in excess of its capacity. Online resources, sufficient books and journals, internet connectivity, reading facility are given to the users. 86% is satisfied.

2) Status of ICT support facility:

College is always eager to keep up with the changing scenario. Despite having financial constraint, the institution has created ICT support facility. 87% seems to be satisfied.

3) Status of working atmosphere:

It is found from the feedback that they regard the working place is second home. Authority is conscious about extending facility to the employees. Conducive atmosphere is given to the employees as far as possible. 84% seem to be satisfied.

4) Status of research facility:

Online resources, leave to attend seminar, workshop, Orientation and Refresher course, to some cases financial assistance are some of the examples that the institution extends to the faculty members.

Broad band internet connection is available. Printing facility is also given.

Besides, a research journal having ISSN is regularly published by the institution.

Authority is seriously considering to create new facilities for the faculty members.

5) Administrative promptness to redress any problem

Authority is responsive and sensitive to the problems and demands of the employees. Various committees are there to take care of the grievances of the employees and to communicate to the authority. Whenever there is any demand or grievance, the authority takes prompt steps to redress it at the earliest.
